1) Name and object of the event

The official title of the event is «**ICS 2018 & XXVI CN TT**», hereinafter referred to as "Event".

Exhibition and sponsorship opportunities are addressed in particular to:

- Heat Treatment & Surface engineering companies;
- Steel and alloys producers;
- Suppliers of Heat Treatment & Surface engineering area, such as producers and resellers of plant and industrial furnaces, plants of induction, heating and quenching, plants for CVD, PVD coatings and so on;
- Suppliers of auxiliary machinery and accessories for Heat Treatment;
- Steelmaking companies;
- Suppliers of steelmaking companies such as producers and resellers of plants, EAF, oxygen converters, AOD, induction furnaces and plasma furnaces, refractories, electrodes, powders and additives and so on;
- Simulation & modelling softwares companies;
- Suppliers of equipment for process control;
- Suppliers of laboratory equipment and machines;
- Suppliers of equipment for safety and environmental protection.

2) Organizers

The Event is promoted and organized by the Associazione Italiana di Metallurgia (hereafter referred to as only "AIM") - Via Filippo Turati, 8 - 20121 Milan and Siderweb spa - Via Don Milani, 5 - 25020 Flero, Brescia (hereafter referred to as only "Organizer").

3) Venue, date and time of the Event

«**ICS 2018 & XXVI CN TT**» will take place at NH Laguna Palace in Venice - Mestre from 13th to 15th June 2018. **Opening hours will be from 8.00 a.m. to 6.30 p.m..** The closing time of the event of 15th June will be 1.20 p.m.. The Organizer reserves the right, at its sole discretion, to change times and date of the event.

4) Admission

Italian or foreign industrial, commercial or manufacturing organizations and their representatives or agents whose activities fall within the scope of the Event are allowed to exhibit at «**ICS 2018 & XXVI CN TT**» (hereafter referred to as only "Exhibitor").

Each Exhibitor may only exhibit in the area assigned by the Organizer (hereafter referred to as only "stand") the goods manufactured or distributed by that company, or products of companies or organizations for which it is the general representative or exclusive agent for Italy. Representatives or agents cannot therefore show other wares than those which they represent as was explicitly stated at the moment of the application. Upon request from the Organizer they shall prove their qualification of exclusive representative or agent for Italy. Exhibitors that have not fully paid the amounts due will not be allowed to participate in the event.

Failure to participate in the Event shall give no right to any reimbursement or indemnity.

An Exhibitor who has not been admitted shall have the right to obtain the reimbursement of the amount paid as down payment.

Applications to participate in the Event shall be without reservations or conditions and must be received by Siderweb spa by no later than **30th April 2018** together with the form and the down payment and/or the balance.

The Organizer, upon its own unquestionable judgment, can take into account applications received even after the deadline.

5) Acceptance of the General Terms

By signing the application form, the Exhibitor undertakes to participate at the event in the stand assigned by the organizer and to accept the General Terms without any reservation, as well as all additional prescriptions that may be issued at any time by the Organizer in the interests of the Event.

6) Registrations and down payment

The application form, completed and signed by the legal representative, must be accompanied by the down payment of 1.500,00 (+ VAT, if applicable).

The above mentioned amount shall be sent to Siderweb spa by means of a bank transfer to: SIDERWEB SPA- via Don Milani 5 - 25020 Flero, Brescia - Taxpayer's Code and VAT number: 03562320170; IBAN: IT73T 03111 54511 000000006864.

Application forms which are not accompanied by the down payment, shall not be considered as valid and therefore will not be accepted. In case the application forms have not been accepted, only the amount paid as deposit shall be reimbursed.

7) Registration of Represented Firms

The Exhibitor is obliged to specify the company name and the relevant data of all the represented companies, whose products are to be presented on the Exhibitor's stand: for each of the represented companies, a registration fee of €100.00 (+ VAT, if applicable) is to be paid.

8) Stand assignment

The stand will be assigned by Siderweb spa and notice will be given by e-mail.

It will only be valid for the Exhibitor stated in the notice, and it is not allowed to totally or partially transfer the assigned stand for any reason, not even free of charge.

If such requirement is breached, the Organizer reserves the right to have the illicitly introduced and exhibited goods removed at the sole expense of the owner of the stand. Stands will be assigned by the Organizers taking account of the general interests of the Event and of the indications given by the applicant. However, the Organizer is not bound by any requests for the position of the stand; these requests, made by the Exhibitor when sending the application request or communicated subsequently, are to be construed as indications and as a preference and do not commit the Organizer in any way. The Organizer reserves the right to change the location and position of the stand previously assigned, or to change its shape or reduce its size, should circumstances so require. The Organizer reserves the right to issue detailed requirements regarding visits and availability of the stands, and the deadline for set up preparation.

9) Cancelling the participation

Siderweb spa is to be immediately informed by registered letter with advice of receipt if an exhibitor is unable to participate in the event. In this case, the organizers will keep the down payment as penalty, provided that the reserved area can be reassigned to another company. If this is not possible, the cancelling company will be obliged to pay the whole amount due under the contract, the costs of the works ordered and carried out, and which cannot be utilized, in the reserved area, as well as any damage caused to the event because of this cancellation.

10) Access to the exhibition area

The entrance to the exhibition area is allowed only with a badge; in the registration fee are included 2 full Conference passes that permit the participation to conferences, lunches, coffee breaks and social event.

By **30th of April 2018** please send to SIDERWEB SPA (commerciale@siderweb.com) the "Form B", here attached, filled with the name of participants. With this form, you can also order extra badges.

11) Participation fee

The registration fee and the participation fee include the following services:

- Exhibition area, with standard equipment;
- 2 full Conference passes that permit the participation to conferences, lunches, coffee breaks and social event;
- Inclusion in the official catalogue;
- Paper catalogue;
- Power supply up to 3 KW;
- Payment of third party liability insurance.

12) Stand arrangement and layout

Stands made available are in line with the indications included in "Form A".

Siderweb spa reserves the right to replace the stands and the relevant furniture with equivalent or higher quality materials.

13) Official Exhibitors' Catalogue

The Event Catalogue will be prepared, without any responsibility for mistakes or omissions, and it will include the list of the exhibiting companies in alphabetical order. The information published is taken from the specific form filled in by the Exhibitor. The deadline for delivering the information forms for the catalogue is **30th April 2018**.

14) Terms of payment

The payment of the balance of the participation fee to Siderweb Spa shall be made by and not later than 15 days of invoice receipt and immediately for the allocations made after **30th April 2018**, under the terms described in part 6 of this regulation. Should the above mentioned payment not be made, Siderweb SPA will not give access to the exhibition area and electricity will not be supplied until the payment has been made.

15) Photos and television shootings

The Exhibitor expressly authorizes Siderweb spa, also through the photographers it has commissioned, to take photographs portraying his personal image, his stand, the exhibited products and the relevant brands and trademarks. Siderweb spa can use the photographs above for journalistic/communication purposes and for promotional and commercial purposes. No use will be made in contexts prohibited by the law or that mar honour and dignity. Posing for and using pictures for the above mentioned purposes is to be considered as carried out totally free-of-charge.

16) Distribution of supports

In case of distribution of audio, video and graphic media or multimedia systems containing intellectual works or parts thereof, protected under Law 633 dated 22.4.1941, copyright must be paid previously as well as the costs for authenticating the media as per article 181bis of the same law. Unauthorised use of intellectual works, and the lack of the SIAE stamp on the above mentioned media, is punishable under criminal law, under articles 171 et seq. of Law 633/41.

17) Insurance

The Organizer does not take any liability that may result from facts attributable to participants in the event, also as for the compliance with regulations on the performance of the event. The Exhibitor is however liable, even if not personally to blame, for all damage to persons or property caused by equipment, facilities and anything else present in the area made available, as well as because of the Exhibitor's own action's or of its collaborators and/or assignees. The Organizer will be in charge of making sure that the Exhibitor is in compliance with the participation procedure and with the payments due to the Organizer, and if it expresses the will to do so, with a coverage against risks of Third Party Liability. Each Exhibitor will then have the option to request additional coverage to insurance agency INSER S.P.A, writing an e-mail to brescia@inserspa.eu by 20 days from the start of the event (please write "**ICS 2018 & XXVI CN TT** organized by Siderweb spa" in the message).

18) Damage to stands

Stands must be returned in the same condition in which they were received. Restoration costs are to be paid by the Exhibitors, who are also responsible for the compliance with the special rules for the use of the facilities and of the technical systems.

19) Supplementary provisions

The Organizer reserves the right to define those provisions which are deemed to be appropriate to best regulate the exhibition and its relevant services.

These provisions have the same value as these General Terms and are therefore equally obligatory. In case of failure to comply with the provisions of these General Terms, the Organizer also reserves the right to close the stands. In this case, the Exhibitor has no right to any reimbursement or indemnity for whatever reason.

20) Force majeure

If it is not possible to hold the event on the established dates, by chance or force majeure, or however for reasons which are independent of the will of the Organizer, the Exhibitors shall have no right to claim damages.

The Organizer can also demand from the Exhibitors up to 30% of the stand rental fee, to cover overheads.

If the Organizer, because of chance or force majeure, is obliged to shorten or cancel the event after its start, the Exhibitor will have no right to the reimbursement of any costs and/or stand rental fees. The Organizer reserves the right, at its own discretion, to change the opening times of the event, as well as to stop entry of visitors or any activity for specific periods, because of organizational needs or for public safety reasons. No liability shall be attributable to Siderweb spa or AIM for such occurrence.

21) Prohibited activities

Anything that can cause prejudice, disturbance or damage to the regular performance of the Event and to its purposes is generally prohibited, and in particular, the following is specifically prohibited:

- the distribution and delivery of any technical, explanatory and advertising material (magazines, manuals, brochures, and so on) which does not strictly pertain to the Exhibitor which, in any case, may only distribute or deliver strictly pertinent advertising material inside that Exhibitor' stand; signs regarding competitions organized by institutions, organizations, newspapers, weekly or specialist magazines cannot be exhibited, not even inside the stand, unless specific authorization is provided by the Organising Secretary in writing;
- any type of pulsating or variable light source;
- remaining in the stand or in the Event area during closing times.

22) Safety

Each Exhibitor is obliged to scrupulously comply with the entire regulatory system in force, regarding the protection of health and physical integrity of workers, as well as juridical, pension and social security regulations for the whole duration of the Event.

23) Obligations and limitations of Organizer liability

The Organizer is liable to the Exhibitor for assigning the stand and for providing the services mentioned in these General Terms, under above mentioned articles 8 and 11. The Exhibitor, in any case, shall keep the Organizer exempt from any liability, within the limitations as per article 1229 of the Italian Civil Code. The Organizer's liability is limited to the payment of an amount equal to 20% of the fee due by the Exhibitor, with the exclusion of any further reimbursement of the latter's damage.

24) Decree Law 196/2003: Privacy Protection

Under Decree Law 196/03, the writing party SIDERWEB SPA, with registered office in Flero, Brescia, in Via Don Milani n. 5, VAT number 03562320170, in its position as Data Controller, informs you about the following: Siderweb spa, in its position as Controller, gathers from you and processes personal data, whose provision is necessary to provide the mentioned services. If refusing to answer, the services requested cannot be provided. With your previous express consent and until such consent is revoked, your personal data will be processed by Siderweb spa also for purposes which are not strictly connected with the provision of the requested services, such as, for example: communication regarding initiatives and services; market research statistics and studies. Your data will be processed by persons in charge of the management of your application, marketing, administration, customer service and can be communicated to third party companies to send promotional material. Personal data will be processed by means of tools appropriate to ensure security and confidentiality, and can be performed also by means of automated tools to store, manage and send the data. Data will however be processed with respect to the principles of data necessity and not data redundancy. In performing the task assigned, the Data Controller can employ persons working under the direct authority of the Data Controller and who have received adequate operating instructions, with specific reference to the adoption of the minimum security measures in order to ensure data confidentiality and security. The Controller can also use third party subjects for specific stages of this activity and, in some cases, is mandatorily obliged to communicate personal data in its possession to government offices or third parties, whose right to process data is acknowledged by specific law provisions, by institutional functions, regulations or by community provisions, or by an explicit mandate from the person concerned. In any case, an updated list of the persons in charge and of any third parties who are recipients of communications of personal data is available at the office of the Data Controller. The person concerned by data processing has the opportunity to exercise all the rights recognized and mentioned under article 7 of Decree Law 196/03 (included below), under the modes of exercise described in articles 8 and 9 of Decree Law 196/03, by getting in touch with the Data Controller as follows writing to: Siderweb spa, via Don Milani n. 5, 25020 Flero, Brescia; by sending an email to: info@siderweb.com

ARTICLE 7 - LAW DECREE 196/03 - RIGHT TO ACCESS TO PERSONAL DATA AND OTHER RIGHTS

The person concerned has the right to obtain the confirmation of the existence or non-existence of personal data concerning him, even if not yet recorded, and their communication in an understandable form.

The person concerned has the right to obtain information about:

- a) the origin of personal data;
- b) the purposes and modes of processing;
- c) the logic applied in case of processing carried out with the support of electronic tools;
- d) Data Controller identification data, data of those in charge and of the representative appointed under article 5, clause 2;
- e) the subjects or categories of subjects to which personal data can be communicated or that may come to know them in their positions of appointed representative in the area of the country, of those in charge or of the persons appointed.

The person concerned has the right to obtain:

- a) the updating and correcting of data and, if interested, additions made;
- b) the cancellation, turning into anonymous form or blocking of data processed against the law, including those for which storage is not necessary with respect to the purposes for which the data were gathered or subsequently processed.

The Court of Brescia has exclusive competence regarding any litigation.

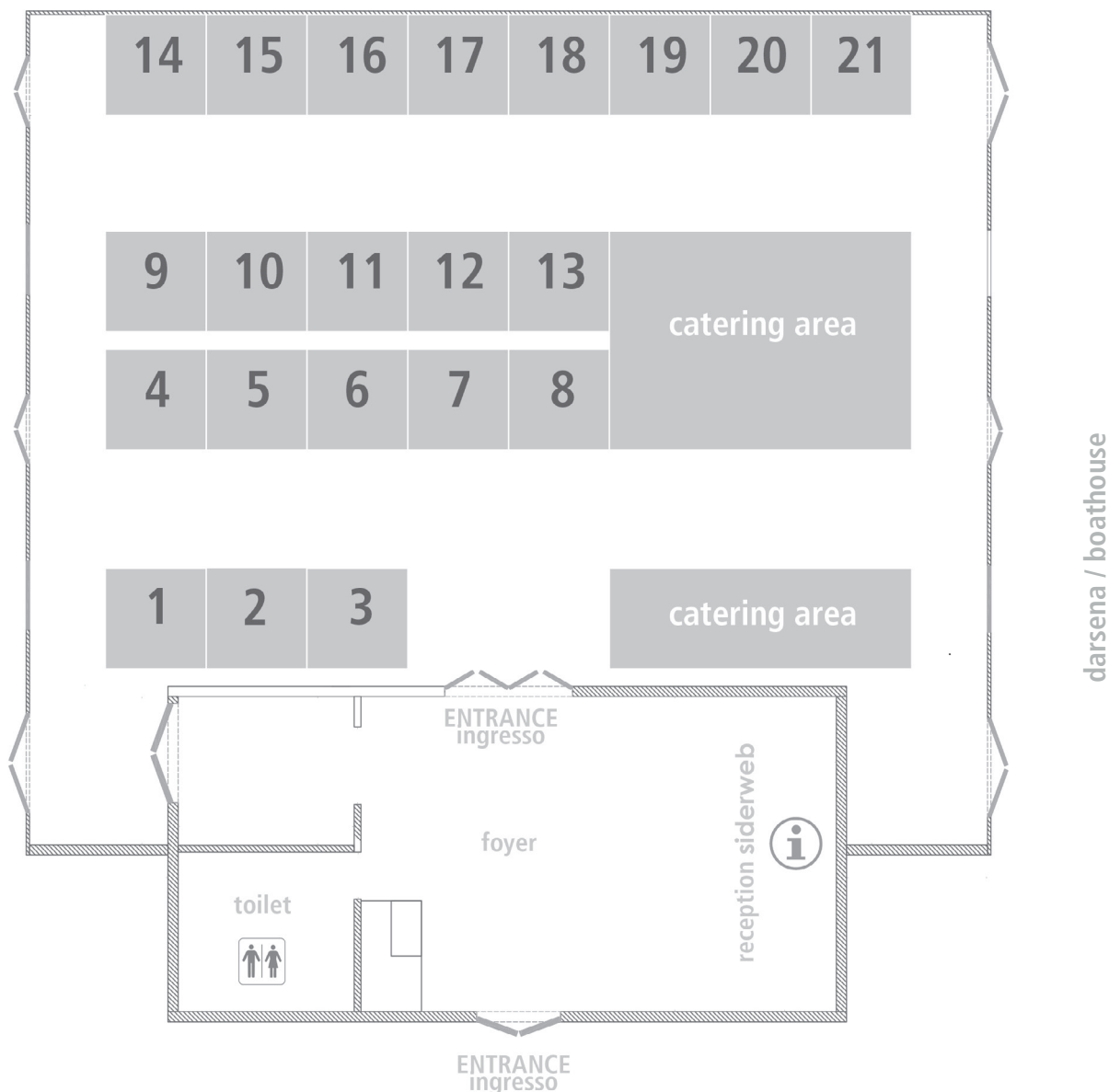

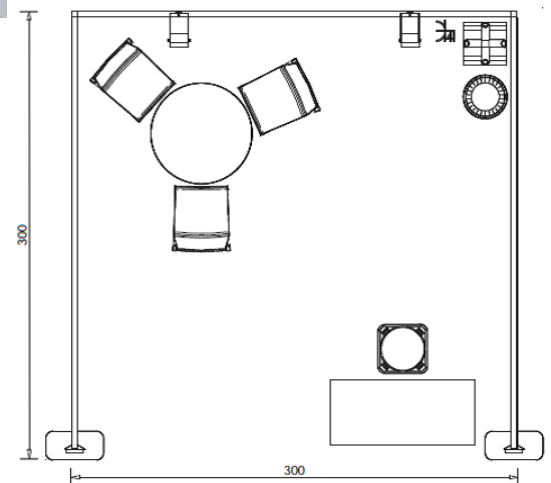
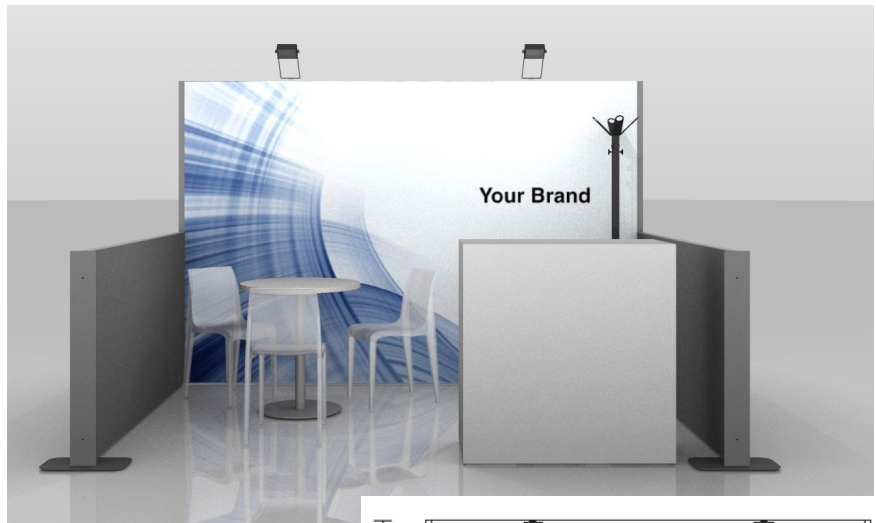
